MVR Shows a Conviction for a Category 4 Disqualifying Violation: (Consider only those entries with occurrence dates between date MVR was produced _____ and date 36 months earlier _____.)

- Driving while under the influence of alcohol or controlled substance, or while intoxicated No Yes
- Refusal to undergo testing for alcohol or controlled substance as required by state or jurisdiction No Yes
- Leaving the scene of an accident involving a motor vehicle No Yes
- Felony involving the use of a motor vehicle No Yes
- Speed contest No Yes
- Negligent homicide No Yes
- Auto theft No Yes

- Reckless driving No Yes

- Permitting an unlicensed person to drive No Yes
- Using false/stolen registration plates on driver's license No Yes
